

## **“FICTION WRITING BASICS” PODCAST AFFILIATE PROGRAM TERMS AND CONDITIONS**

Thank you for considering the MJV Services Fiction Writing Basics Affiliate program. Please read the following terms and conditions very carefully, before completing the enquiry form. If you have any questions, please contact us at [authors@mjvliterary.com](mailto:authors@mjvliterary.com).

In this agreement, the term "Affiliate" refers to you (the applicant). In this agreement, “Fiction Writing Basics” refers to a product of MJV Services, with whom you are entering this agreement. By applying to the Fiction Writing Basics affiliate program you are confirming that you have read the agreement and agree to the terms and conditions, and that you are engaging into a relationship with MJV Services.

### **Affiliate Program**

We offer a straightforward commission for converted referrals, at a rate of 40% of the Fiction Writing Basics gross retail price, currently £8.50 per download. We do not offer any commissions for non-converted referrals.

### **Commissions**

For a sale to generate a commission to an Affiliate, the customer must complete the purchase and remit full payment for the product. Commissions will only be paid on sales that are made in the same visit that the customer has made when clicked through a qualified, correctly verified Affiliate URL link.

Properly coded links are the sole responsibility of the Affiliate, and should not be shared under any circumstances. We cannot be held responsible if you have referred a sale which has tracked through an incorrectly affiliated URL, unless our error or our system are found to be at fault. Commissions can be viewed on your Affiliate dashboard, and are usually updated within 48 hours. However, this may on occasion take longer due to circumstances beyond our control.

## **Sub-Affiliates**

You are welcome to recruit a sub-Affiliate network, but all of your Affiliates and related websites, blogs and social media profiles must be approved by us and given their own unique referral URL by us. You will have access to their Affiliate link and referral statistics via your Affiliate dashboard.

We will not be responsible for remunerating your sub-Affiliates; their commission will be payable from your own, via whichever at whichever proportion is agreed between you. We will be in no way responsible for resolving remuneration disputes between you and your sub-Affiliates, however, we do reserve the right to intervene in order to request cancellation of your relationship in respect of Fiction Writing Basics at any time and for any reason.

Your sub-Affiliate must agree to our terms and conditions.

## **Payment**

An Affiliate can request payment at any time their balance reaches a minimum balance of £10 GBP. Payments will generally be paid out via PayPal, and Paypal terms and conditions may apply. As part of the Affiliate registration process, we will require you send us a payment method, which may include your bank account details or Paypal account details. We are not responsible for covering any transfer costs or fees which may be imposed by Paypal or your bank account. In order to retain your financial and personal data, if you are an EU citizen, please note that you will be required to agree to our GDPR requirements.

## **Refunds**

In the event a customer requests a refund for a transaction for which the Affiliate has earned commissions, any commissions earned on the refund amount are repayable and will be deducted from the Affiliate's balance.

## **Usage and Obligations**

Affiliates are permitted to use the MJV Services brand and marketing resources which we permit, on websites, blogs and social media profiles which we have approved. Logos, banners and other promotional materials cannot be modified, and Affiliates are not permitted to design their own. The Affiliate does not gain any trademark, copyright or any other rights to these materials.

The Affiliate will never represent themselves, MJV Services or their relationship with Fiction Writing Basics in a false or misleading way.

The Affiliate will not engage in the distribution of an unsolicited bulk email (spam) mentioning or referencing MJV Services or Fiction Writing Basics.

The Affiliate must engage in our code of conduct, ethics and general decency. We will not permit Affiliation by any website, blog or social media profile we deem to be pornographic, indecent, immoral, unethical, detrimental to child or animal welfare, racist, sexist, homophobic or discriminatory, and we reserve the right to terminate your Affiliation immediately and without notice, for any reason we choose.

## **Term and Termination**

There is no fixed term or contract implied by this Agreement. Either party has the right to terminate the agreement immediately without prior notice, and without any reason given.

If we terminate your affiliation, you are requested to remove all MJV Services and Fiction Writing Basics promotional materials from your sites/profiles immediately and without delay.

If either party terminates the agreement, no future commissions will be payable from the time of cancellation. The Affiliate will be remunerated in full the balance of their account within 7 days.

## **Arbitration**

All claims and disputes arising under or relating to this Agreement are to be settled under jurisdiction of the courts of the UK and, if relevant, the EU.

## **Modification**

We reserve the right to change any of the terms and conditions within this Agreement at any time and at our sole discretion, including future commission payable, though not retrospective commission.
